5. **Roy Sheppard III** – Area Variance for proposed detached garage closer to the street than the street wall of the dwelling. Property is located at 258 Spruce Road. Tax Map Section 72; Block 1; Lot 9; is approximately 2.20 acres, and lies in the Residential Agricultural Area.
6. **Alfred Salatino** – Area Variance for proposed addition to expand existing rooms in existing single family dwelling, too close to side property line. Property is located at 25 Hamilton Road. Tax Map Section 13; Block 3; Lot 11, is approximately 0.69 acres, and lies in the Hamlet Center Zone.
7. **Todd Lyons Living Trust c/o Alayna Waizenegger** – Area Variance for a proposed *in-ground pool* in the front yard. Property is located at 523 Old Mountain Road. Tax Map Section 72; Block 1; Lot 37, is approximately 185.56 acres, and lies in the Ridge Valley Protection, Residential Agricultural Zones with the Shawangunk Ridge Protection Overlay .
