Be advised of Sullivan County local Law #13 of 1977 regarding the use of licensed electrical contractors and Town of Mamakating Code 85-2 regarding creation of the electrical inspectors and setting forth duties and violations thereunder. It is required that electrical work performed shall conform to all local, state, and national electrical codes and shall be inspected by a certified inspector who has been accepted and registered by the Town of Mamakating Building Department. The application for inspection must be completed by the person performing the electrical work and sent to the local registered electrical inspector of choice. Any rough wiring must be inspected and approved prior to covering walls with insulation, sheetrock, paneling, etc. A final electrical inspection must be made and approval obtained before issuance of a Certificate of Occupancy.
